 A 38 year old woman from Pendleton was passing a Commercial Motor Vehicle on the right when the CMV all the sudden started signaling and immediately moving over pushing the woman and her 2023 white Jeep Grand Cherokee to the shoulder. The front right corner of the CMV clipped the left rear bumper of the Jeep. The woman hit her flashers and came to a stop partially blocking the right lane. The CMV stopped behind her then went around her and continued westbound. Approximately one mile later the woman pulled in behind a State Trooper and the CMV pulled over a short distance later, but then took off again. The woman pulled out, caught up with the truck and provided the police with the CMV's license plate. Troopers were able to get the CMV driver stopped, a 37 year old man from Beaverton, who stated that he didn't think he hit the Jeep. He stated that he believed the Jeep had just brake checked him and he didn't see any need to report that to the police. He stated that people come to a stop in front of him on the freeway all the time. The male was cited and released for Failing To Perform The Duties of a Driver in a crash with property damage.
