Narrative summary
 Oregon State Police Troopers and Hood River County Sheriff's Deputies located the suspect vehicle of a driving complaint. Multiple 911 centers received complaints of reckless driving on a gray Nissan Versa. The license plate returned to a stolen Nissan Versa out of Pierce County, Washington. The driver displayed numerous signs of alcohol impairment and consented to field sobriety tests. Only one test was performed for safety reasons, but the driver performed poorly. He was arrested for DUII, UUMV and Reckless Driving. The stolen vehicle was recovered and Guzman Brothers responded for the tow. The suspect was transported to the Hood River Sheriff's Office, where he refused to submit to a breath test. A warrant was requested and granted, and a legal blood draw was executed at Providence Hood River Memorial Hospital. The suspect was lodged at NORCOR.
